That in consideration of the use of the facilities and property of Operators and in addition to the fee paid for such use, Participant agrees as follows: 1. That Participant voluntarily and knowingly assumes all risk of accident, injury to person and damage to property arising out of his/her use of the facilities, property, and equipment owned and furnished by Operators. 2. That Participant hereby releases and discharges Operators from any claim, liability, or demand of any kind or on account of any personal injury or damage of any kind sustained by Participant, whether caused by the sole or concurring negligence of Operators, or otherwise. 3. That Participant will indemnify and save Operators harmless from any claim, liability or demand of any kind including attorney fees and costs for or on account of any personal injury or damage of any kind sustained by Participant whether caused by the sole or concurring negligence of Operators or otherwise.
