## Release and Indemnification Agreement

That Participant voluntarily and knowingly assumes all risk of accident, injury to person and damage to property arising out of his/her use of the facilities, property and equipment owned and furnished by Operators. 2. That Participant hereby releases and discharges Operators from any claim, liability or demand of any kind or on account of any personal injury or damage of any kind sustained by Participant, whether caused by the sole or concurring negligence of Operators or otherwise. 3. That Participant will indemnify and save Operators harmless from any claim, liability or demand of any kind including attorney fees and cost for or on account of any personal injury or damage of any kind sustained by Participant whether caused by the sole or concurring negligence of Operators or otherwise.
